Florida Real Estate Education Requirements

You can take the course online or in a classroom at a real estate school or at Realtor associations and boards statewide. Course packages vary from \$100 to \$500. You must pass the exam with a score of at least 70 percent. NOTE: If you're approved to practice law in Florida, you don't need to take the pre-license course.

How to Get Your Florida Real Estate License

The state of Florida uses Pearson VUE for their testing services. First you must apply for your license with the Florida Division of Real Estate (DRE), then you must register with Pearson VUE by calling (888) 204-6289. You must do both before you may take the state licensing exam.
